

ORDINANCE NO. 2016-02
AN ORDINANCE TO ADOPT THE TOWN OF WESTFIELD, WISCONSIN
COMPREHENSIVE PLAN

The Board of the Town of Westfield, Wisconsin, does ordain as follows:

SECTION 1. The Town of Westfield is authorized to prepare and adopt a comprehensive plan as defined in Sections 66.1001(1)(a) and 66.1001(2) of Wisconsin Statutes.

SECTION 2. The Board of the Town of Westfield has adopted and followed written procedures designed to foster public participation during the comprehensive plan adoption process as required by Section 66.1001(4)(a) of Wisconsin Statutes.

SECTION 3. The Plan Commission of the Town of Westfield has adopted a resolution recommending to the Town Board the adoption of the 2015 Marquette County Comprehensive Plan to also serve as the Comprehensive Plan for the Town of Westfield. The 2015 Marquette County Comprehensive Plan contains all of the elements specified in Section 66.1001(2) of the Wisconsin Statutes.

SECTION 4. The Town of Westfield has held at least one public hearing on this ordinance, in compliance with the requirements of Section 66.1001(4)(d) of Wisconsin Statutes.

SECTION 5: The Town Board of the Town of Westfield, Wisconsin, does, by enactment of this ordinance, formally adopt the document entitled, *2015 MARQUETTE COUNTY COMPREHENSIVE PLAN*, as the Town of Westfield Comprehensive Plan pursuant to Section 66.1001(4)(c) of Wisconsin Statutes.

SECTION 6: This ordinance shall take effect upon passage by a majority vote of the members-elect of the Town Board and publication/posting as required by law.

**TOWN OF WESTFIELD PLAN COMMISSION RESOLUTION 2016-01
RECOMMENDING ADOPTION OF THE 2015 MARQUETTE COUNTY
COMPREHENSIVE PLAN AS THE TOWN OF WESTFIELD COMPREHENSIVE
PLAN**

WHEREAS, §66.1001(4), Wis. Stats., establishes the required procedure for a local government to develop and adopt a comprehensive plan; and

WHEREAS, the Town Plan Commission has the responsibility under §66.1001(4)(b) to recommend that the Town Board adopt a Town Comprehensive Plan; and

WHEREAS, the Town of Westfield Plan Commission has considered adoption of the 2015 Marquette County Comprehensive Plan, which was prepared under the authority of and procedures established by §66.1001(4) Wis. Stats., to also serve as the Town's Comprehensive Plan; and

WHEREAS, the 2015 Marquette County Comprehensive Plan contains a Planned Land Use and Farmland Preservation Map developed by the Town, which accurately reflects the Town's wishes and desired future land use pattern; and

WHEREAS, the Commission believes that Town adoption of the County Plan is the most appropriate and cost-effective way for the Town to meet the State's comprehensive planning requirements; and

WHEREAS, the Town has reviewed the 2015 Marquette County Comprehensive Plan, containing all maps and other descriptive materials, and found that it should be adopted as the comprehensive plan for the Town under §66.1001, Wis. Stats.; and


NOW, THEREFORE, BE IT RESOLVED that the Town Plan Commission hereby recommends that, following a public hearing, the Town Board adopt an ordinance to constitute official Town adoption of the 2015 Marquette County Comprehensive Plan as the Town of Westfield Comprehensive Plan under §66.1001, Wis. Stats.
